

We are pleased to make available to our Providers a service that enables you to view eligibility and claim information online. ¹ You can also view patient deductibles and stop loss accumulators, plan documents, and your Provider Payment Reports (PPR) for paid claims.

Getting Started

To access Online for Providers, you will need your Tax Identification Number (TIN) and your login password. If you do not have a password, please request one through Provider Relations (see Contact Information section).

Online for Providers is a secure Website. Your Provider ID and password must be protected and used only by the practice to which it was assigned. It is your responsibility to maintain and protect your ID and password, and to contact our Provider Relations Department if you forget or lose your password.

Logging In

The Website address for Online for Providers is: https://www.hmaaonline.com

On the Home Page (Figure 1.1), you will see two choices: Provider and Member/Dependent.

Choose the first option, **PROVIDER**. This link will direct you to the Provider Login Page (Figure 1.2). Enter your Provider ID (your tax ID number) and password and select [I Accept]. You are now logged into Online for Providers.

View Plan Information

Enter a patient's member ID from his or her insurance card and select [Submit] (Figure 1.3). If you don't have the patient's member ID but have their Social Security Number (SSN), you may enter the SSN and choose SSN as the ID type in the drop-down box. From here, you have several options. To access these options, select the links in the sidebar or on the main page (Figure 1.4 & 1.5). You may:

- 1. Check Eligibility
- 2. View patient's plan documents *Important:* If you are using Adobe Acrobat Reader and an incorrect PDF appears, please refresh your browser.
- 3. Check your in-process and paid claims
- 4. View Patient Accumulators **Note**: If the patient has Single Coverage, you may see accumulators relating to Family Coverage. Please disregard the Family information as it is not applicable.
- 5. View your Provider Payment Reports (PPR, Figure 1.6)
- 6. Download forms
- 7. Link to other related websites
- 8. Update your password
