



# Active&Fit® Enterprise™ Program Rider

<b>Monthly Premium</b>	\$4.52 per employee / up to \$13.54 per family
<b>Eligible Groups</b>	Employers that have HMAA’s medical coverage may elect this rider. <b>All</b> eligible participants covered by the medical plan must be included in the rider benefit. Employees who are not covered by the medical plan are not eligible for the rider benefit.
<b>Eligible Participants</b>	Employer-sponsored plan. Employer may choose to offer this rider to Employees only, <b>or</b> Employees and Dependents. Fitness membership minimum age is 13.

## Fitness Center Membership

Fitness Center Membership	Eligible participant pays a non-refundable fee per month for access to thousands of participating fitness centers nationwide. Members may access multiple fitness centers such as 24 Hour Fitness and YMCA at a low monthly cost of \$10, or select a single gym membership from the expanded network in Hawaii (e.g., UFC Gym or CrossFit) at a higher monthly cost. Monthly cost varies by fitness center. <sup>1</sup>

## Home Fitness Program

Home Fitness Kit	Eligible participant pays a \$10 non-refundable annual fee for one kit per benefit year (includes equipment) and may opt for this simultaneously with Fitness Center Membership.

## Features

Online Tools	Track your activity with the Active&Fit Connected!™ tool <sup>2</sup> , a fun and easy way to track your exercise at a fitness center or through a wearable fitness device or app.

Monthly premium rider is paid by the Employer for each employee with medical coverage, regardless of whether they or their dependents enroll in fitness membership. Active&Fit member fee is paid by the Eligible Participant. The Employer may choose to supplement or reimburse the member fee.

Fitness member fee is due monthly. Membership may be canceled at any time after the initial 2-month commitment. Member’s benefit year is based on the effective date of the **group’s rider coverage** (e.g., Jan. 1 to Dec. 31 if the group’s Active&Fit rider coverage is effective Jan. 1). Your medical plan renewal date may differ.

In the event of termination of the group’s Active&Fit Program rider or termination of the Eligible Participant’s HMAA Medical Plan eligibility, the Eligible Participant will no longer receive the Rider Benefits after such termination date. Reinstating an Active&Fit membership thereafter requires re-enrolling in autopay for the Fitness Center Membership monthly fee or Home Fitness annual fee.

The Employer shall be responsible for all coverage notifications to Eligible Participants.

If the Employer elects Employee+Dependent coverage, rider rates are charged on **each** employee based on their medical coverage type (two-party, family, etc.), regardless of whether the employee’s dependents are eligible for the program (i.e., under age 13) and whether they enroll in fitness membership.

## Active&Fit Direct™

HMAA also offers the **Active&Fit Direct** Program at \$28 per month plus an enrollment fee and taxes. This program is not employer-sponsored and does not require an enrollee to be covered by an HMAA medical plan. Please note the list of participating facilities differs from that of the Active&Fit Program Rider.
